## Guideline Change Overview

- Collaborative effort between LCBO and Industry
- Intend to implement later this year, once we see some stabilization in the hospitality industry
- Intent of changes are to:
  - Improve ordering flexibility
  - Enable continued growth and access for all agents
  - Create efficiencies

## Private Ordering Changes

- Removal of Private Orders for all agents
- Creation of entry level Consignment Tier to facilitate ordering
- Addition of paid security flex space of up to 200 cases

- Security deposit of \$75/case of desired threshold space
- Security deposit to be refunded on exit from program in good standing

### Consignment Program Tier Structure

#### Tier 1

Space allocation based 6 Turns of Sales

#### Tier 2

400 Cases OH 400 Cases IT

#### Tier 3

325 Cases OH 325 Cases IT

#### Tier 4

250 Cases OH 250 Cases IT

#### Tier 5

175 Cases OH 175 Cases IT

#### Tier 6


80 Cases OH 80 Cases IT

Facilitate sales of > 2,500 cases

Facilitate sales between 2,000 and 2,499 cases Facilitate sales between 1,500 and 1,999 cases Facilitate sales between 1,000 and 1,499 cases Facilitate sales between 500 and 999 cases NEW
Facilitate sales
under 500
cases

## Consignment Changes

- 4 seasonal consignment threshold adjustments
- Increase minimum Consignment order to 20 cases/item
- Additional space calculated as 10% of agent Consignment threshold to be allocated for orders where quantity/item is less than minimum
- Qualification for HVC reduced to 200 cases sold in last 12 months for an item



## Consignment Changes

- Exception for products with vendor quotes over \$20/bottle CAD
- Payment terms will be on a period basis to align with LCBO's fiscal calendar for payment on depletion of PO's for Consignment and HVC orders
- The option to order multiply items under the same Consignment Purchase Order.
- Product seizure timelines changed to 365 days



## Storage Fees

- Storage fees will be consistent across all programs (Seasonal, Consignment, HVC) as outlined in chart below
- Handling fee will be consistent across all programs at \$1.05/case at time of receipt

## Administration Fees



- Vendors to be charged for all corked product returns, in line with the handling through Retail channels
- Escalating fees for non-compliance shipments and associated rework/corrective fees including incorrect case markings
- Applicable fees for corrective PO, PO cancellation and PO reprice
